The NCA Members-Only Website: As a member of NCA, you will have access to the CAC members' dashboard of the NCA website. You can subscribe to our newsletters and Listservs on the NCA website!

CACInfo Listservs: NCA's Listserv community was launched in June of 2000. It was developed to provide a member forum for exchange of information and ideas through electronic dialogue. Authorized users (subscribers) send email messages to the Listserv address (<u>cacinfo@mail.nca-online.org</u>) and these messages are distributed to everyone who is a subscriber of NCA's Listserv community, where they can respond and join the conversation.

NCA Listserv: The main Listserv is unmoderated. The software automatically distributes all incoming messages to all subscribers without review or modification. The Listserv is subscriber-approved. Those who wish to subscribe must submit a request via the online request process. Subscription requests will be reviewed and approved before you will receive the benefits of using the NCA Listserv.

Approved subscribers are key staff of Accredited, Associate/Developing, Affiliate, and Satellite NCA member centers, Chapter representatives, NCA Board members, Regional Children's Advocacy Center staff, approved NCA site reviewers, and NCA staff.

The Listserv does not have archival capability. Messages that are posted to the Listserv are **not** maintained in a central location for later reference. Subscribers may want to set up a separate folder within their email software to save messages for future reference.

The NCA BrandFolder: The NCA BrandFolder contains the NCA logo and badges, as well as brand assets, key documents, and public awareness campaigns for the use of authorized NCA member organizations.

Regional Children's Advocacy Centers

Working in collaboration with NCA are four Regional Children's Advocacy Centers (RCACs). The RCACs were established by the U.S. Department of Justice's Office of Juvenile Justice and Delinquency Prevention through competitive grants to provide technical assistance and training to CACs and MDTs in four census regions. They are funded separately from both NCA and local child advocacy centers, but under the overarching umbrella of the Victims of Child Abuse Act. RCACs offer a wide variety of excellent programming, including customized training and consultation; MDT training; leadership coaching and exchange; and a robust array of online training and webinars for MDT professionals. NOTE: Blake is not your first point of contact if you are experiencing a critical incident. **If you or one of your members are experiencing a critical incident that may have implications in the media, you must file a Critical Incident Report** (CIR) with Director of Membership and Chapter Development Kristie McKenney at <u>kmckenney@nca-online.org</u>. Our team will review the CIR immediately and respond, bringing in Blake to develop a crisis communications plan, including help with handling media, if the Membership team believes such a plan is needed in your incident.

Fundraising and Resource Development

Bryan Boeskin, senior director of development, and **John Douglas**, development manager, are on hand to support your Chapter's fundraising and development efforts in a number of ways, including:

- Partnering with Chapter directors to seek funding for statewide and regional projects/programs. Recent examples include the CFTSI implementation project in North and South Carolina and the evidence-based mental health assessment project in Mississippi.
- Notifying Chapters of funding opportunities in the state/region.
- Offering guidance on preparation of funding proposals, approaching funders.
- Offering guidance on developing fundraising programs/fundraising plans.
